3. Purpose

Profit will be determined after the expenses of raffle prizes, commissions and any major marketing material created for the raffle are subtracted from the sales of the raffle.

4. Eligibility

- Entry is only open to NSW residents aged **18 years or over**.
- Management of the promoter, and any person involved in the conduct or management of the raffle or any benefiting organisation, including their immediate families, are not eligible to enter.
- By purchasing a ticket, entrants agree to these Terms & Conditions.

5. Raffle Period

- Ticket sales open: **1 May 2026 at 9:00am (AEST)**
- Ticket sales close: **13 August 2026 at 7:00pm**
- The promoter reserves the right to extend the closing date if required and approved by NSW Fair Trading.

6. How to Enter

The raffle will operate as a single campaign over the approved sales period. Tickets will be sold at tiered pricing levels to encourage participation and maximise fundraising outcomes. Ticket pricing will be clearly displayed to purchasers prior to payment and will include the following options:

There is **no limit** to the number of tickets an individual may purchase. There is no maximum number of tickets available for sale.

7. Draw Details

- The draw will be conducted **live on Club Maitland City's Facebook page**
- Winners will be drawn randomly using the RaffleTix electronic draw system in accordance with NSW Fair Trading requirements.
